

REGISTRATION AND TUITION AGREEMENT 2009-2010

This agreement is made and entered into between Montessori Arts and Sciences School and _____, Parent/Guardian. Montessori Arts and Sciences School accepts your child _____, for enrollment in the School for the 2009-10 academic year. Children are accepted only for the entire school year or for the remainder of a school year after the starting date.

If circumstances require that a student be withdrawn from the School, the School must receive written notice at least 30 days prior to withdrawal. Upon withdrawal from the School and said notification has been received, a tuition refund shall be made to the Parent or Guardian, if the tuition has been paid annually or by semester. Please note that tuition is based on enrollment and not attendance. No credit is given for illness or vacation. Your child has a space reserved for the academic year, and since the School does not accept new entrants into the current school year after March 1, the balance of the tuition through June for the stated school year will be due for any child withdrawn after that date.

Tuition may be paid in full, per semester or in ten installments due the first day of each month, September through May, according to the Tuition Schedule and Registration and Tuition Agreement. In order to provide and reserve a space for your child in the School, a ten percent tuition prepayment is required with this document. This payment holds a place in the appropriate class in Montessori Arts and Sciences School for your child and is non-refundable. A Late Fee Charge of \$35 will be accessed if tuition is not paid by the 10th of the month. Interest may also be charged at the rate of 1 1/2 % per month for the additional late tuition payments.

All registration forms must be completed and returned to the office prior to the student's attendance. These include Statement of Intent, Previous School Records, Teacher Recommendation, Health Records, Emergency Information, Transportation Form and Student Information.

Montessori Arts and Sciences School shall have the right to exclude any child from attendance, temporarily or permanently, who is deemed by the Director to be interfering with the health, safety or educational development of himself/herself or any other child in the School. If your child is asked to be withdrawn, Montessori Arts and Sciences School will retain the June prepayment, fees and one-tenth of the annual tuition.

I/We choose the following option for payment of tuition and fees:

TUITION:

A single annual payment of \$6,460, due June 1, 2009. This reflects a 5% prepayment discount and balance due after the \$760 Registration payment.

Two payments of \$3,325 due June 1, 2009 and January 1, 2010. This reflects a 2.5% discount and the balance due after the \$760 Registration payment.

Ten monthly payments of \$760.00. The first payment of \$760 is due and payable at the time the application is accepted, or for returning students must be received by June 1, 2009. The remaining payments will be made the 1st of every month, September through May.

FEES:

A single annual payment of \$1000.00 due June 1, 2009.

Two equal payments of \$ 500.00 due July 1, 2009 and August 1, 2009.

Two equal payments of \$ 500.00 due June 1, 2009 and January 1, 2010.

Ten monthly payments of \$100.00. The first is due and payable at the time the application is accepted for new students and June 1, 2009 for returning students. The remaining payments will be made the 1st of every month, September ,2009 through May, 2010.
